We provide critical guidance on contracts you ask others to sign and contracts that parties ask you to sign. In some cases, risk is appropriately transferred so the responsible party can

contractually assume their share of liability. CIRMA's Contract Review team will work one-on-one with you and make recommendations, including, but not limited to:

- Waivers of subrogation
- Insurance requirements
- Indemnification language
- Additional insured status
