The class will collaborate on decision making, applicable to all levels of Use of Force from Handcuffing through Deadly Use of Force. In essence, every officer will have the opportunity to offer their knowledge, experience and opinion to help the entire class reach some sound conclusions. Case law will be updated to the week of the class presentation providing officers with the most recent application of legal standards.

The course will focus on current liability issues in Connecticut pertaining to use of force in investigative detentions, forced entries, searches, arrests, dealing with emotionally disturbed persons, self defense and defense of others and de-escalation.
